A short-legged, straight fronted dog should not be photographed in full profile, and especially not in long grass.



This four-month-old actually DIS grow into his ears, and his head DID broaden. He now has a lovely head but no one should use this picture of him in an advertisement.



This picture shows a dog "under reaching." Notice how the forefoot and the hindfoot do not meet under the dogs body. The rear leg at full extension seems to be kicking up. Also, if your dog is longer in body, perhaps a side movement shot is not the best for your dog, as he may appear even longer.

"A Picture is Worth....or, What Pictures Can Teach Us About the Standard, and How to Use Only Good Pictures in Advertising."

Following the meeting of the Northern California Siberian Husky Club on 10/12/2013, Club Member Donna Beckman held a slide show presentation on the above subject. The presentation is designed to help Siberian fanciers select appropriate photos for advertising, posting on our websites, or simply posting on our Facebook pages.

The slide presentation offers a wide range of photos of many styles and types of Siberians. Donna asks us to look at each slide and determine whether or not we would use the photo for advertising. Many of the photos are very obvious, dog is too long or short in body, dog lacks leg, lacks length of neck, too straight in the front or rear. But many are quite deceiving. The photo looks perfect for advertising until Donna superimposes lines with the proper lengths and angles for a Siberian as written in our standard. It then becomes obvious that the dog in the photo lacks upper arm, is slightly too long or short, does not have quite the proper angle in the front or rear, etc.

One interesting observation in the slides is that the way the dog is positioned in a photo can sometimes give an illusion of something being off when in fact the dog is better than the photo shows. We all know that some dogs just aren't photogenic.

Donna also presented many movement shots to show different faults that show up in movement photos and how the way the dog is positioned when the photo is taken can give different illusions the same as a standing photograph.

The presentation was very well attended and I believe everyone was able to take something away afterwards. I know I will never look at my photos the same way again. Although it would have been nice to see some more folks from the dog show community attending as we are the ones who have websites and do the most advertising.

Thanks to Donna for the wonderful and informative presentation, thanks to club member Randee for making her house available for the presentation, and thanks to everyone who attended.





These are pictures of the same dog. Notice how in the left-hand picture, the body looks compressed due to the inside legs meeting. With the inside legs at full extension, the picture at the right is a much more appealing one.
