Laurissa Schmidt offered Yesieska's Frostnip "Nini" to Kelley and I shortly after Ranger's fatal illness. Burney was mourning and not doing well as a only dog. So in January 2014, Kelley and I made a snowy trip to Wyoming to meet Laurissa half way. At our first meeting, Nini wanted nothing to do with either of us or Burney and hid behind Laurissa.

In a short time she warmed up to Burney and Kelley and her husband, Marc. But for several months each time she saw me come into the yard at Kelley's house, she would hid in her dog house. I had to crawl on my hands and knees after her to put a leash on, then drag her out to go to the obedience classes I had enrolled her in. She was a quick learner and obeyed commands readily. Gradually I began to see a change in her attitude. She began to come to me when I came over and would run out to the van ready to jump in when I came by. By June, she had passed her CGC (Canine Good Citizen) and in July she qualified for her first two legs in Rally Novice. She completed her RN title in August with one score of 96 of 100. At the SHCA National Specialty, she received a 4th place in the Rally Novice B competition. Ten of the points we lost, were due to my error, not hers. I was very proud of her and how far she had come in the nine months. She has become much more accepting of strangers and being in strange situations. I attribute all of this to obedience training which has given her confidence.
